#### **4. Guest Presentations** (60 minutes) --

4.1 Jennifer Shanoski, President of the Peralta Federation of Teachers –
Shanoski shared a presentation about the campaign Peralta adjuncts engaged in to get
parity. She went over various elements of a nearly ten-year campaign – from defining parity
(hourly) to slogans and tactics in getting their FT members on board and pushing the Admin and
the BOT to make the right choice.

Slogan: Equal Pay for Equal Work

Nearly a ten-year fight.

# Some highlights of the parity fight:

First big win was 2014 – same kind of salary schedule (step and column) as FT. Once the schedule was out there, it was comparable with FT so you could make the slogan clear.

2017 -- 50/50 campaign – half the total dollars of a 3.5% across the board raise would go to FT and half of the total would go to PTers.

19-20 contract campaign got halfway there

20-21 reopener on parity where it was already agreed that if the money was there it would be devoted to finishing the trek to parity.

Got a lot of community partners in the process. Demonstrations on Flex Day. Willing to embarrass the chancellor – Brd Meetings but also public appearances of chancellor.

Also, a political campaign. BoT, mayors, assembly members, etc.

Ratification was a big party – why? – she speculates that nearly half the faculty had showed up to at least one event and so had a buy-in.

What to do now? Increase FT positions, expand benefits, pay for service work, and expand to statewide.

Shanoski was thanked for her very useful presentation.

4.2 Guests, Bethany Hazen Johns, District Research, Jerome Countee, and Kira Tippins, Dean of Student Service at CCC gave a Compressed Calendar Presentation (with Q&A)

The committee is charged with investigating moving from 18 to 16-week semesters – without loss of instruction time. Their charge is to determine the best way to transition and make a recommendation to Cabinet.

Bethany gave a detailed presentation about impacts – whether outcomes changed due to calendar compression. Cutting to the chase, there seems to be little statistically significant change in outcomes for students.

In Q&A, some concern was raised that data hasn't been disaggregated for disparate impacts.

There are some concerns over operational challenges for staff.

There was some discussion of moving to a trimester (two semesters with an inter-session) and the problems with 4-6 week classes.

It would most likely take about 6 years to transition if such a thing was decided on. She left a place for questions and concerns.

Rebecca Nelson, who is a member of the committee studying the issue, argued that there is little reason to change.
